9. Reports
i. President's Report

The President, Gill Hallam, reported on achievements in the Association's five key areas - members, communication, education, innovation and learning and finance and management – and encouraged members to read the 2005 Annual Report for details of these.

Highlights included membership growth and excellent member retention. The Association had recognised individual member achievement through a number of awards and had also awarded scholarships to enable members to undertake research activities. Following its application to the Australian Taxation Office, the Association had been granted Approved Research Institute/Deductible Gift Recipient status which means that donations to the ALIA Research Fund are tax deductible.

During 2005 many events had been organised including many professional development opportunities for members at both national and local levels. Other events included those organised for Library and Information Week, sponsored by NetAlert, major organising responsibilities for National Simultaneous Storytime as well as other important involvement in the National Broadband Strategy and organisation of the Digital Amnesia seminar. The Association had also been involved in lobbying and advocacy activities of major importance to the profession. An example of this is the 2005 Survey of Internet usage in public libraries which the Association had undertaken and which will inform further developments of the broadband strategy.

The year has seen the appointment of a new Executive Director and some refocusing on priorities. The President thanked the Board of Directors for their support and ALIA National Office staff, including local liaison officers for their work during her period as a director.
